

## Extinguisher used to put out kitchen fire in house near Oakland

An extinguisher was used to contain and put out a kitchen fire late Sunday afternoon in a house along Illinois Route 133 about a mile west of Oakland. Assistant Chief Kyley Willison of the Oakland Fire Department said the fire started at approximately 4 p.m. after the occupant of the house forgot that the kitchen stove was turned on and the items on top of the stove caught fire. He said flames engulfed the stove and spread to adjacent cabinets before the occupant was able to extinguish the fire. Willison said Oakland firefighters were dispatched to the scene, where they subsequently removed the charred stove from the kitchen. Firefighters were on scene for about an hour.

Blicharz's quick response resulted in the safety of the family and minimal damage to the house, according to the release.

## Pittsfield children, mother save house from burning

One Pittsfield family is safe and sound as the result of a group effort between a mother and two children to report and put out a fire on Tuesday night. According to a preliminary report from the Pittsfield Fire Department a fire apparently broke out in a bathroom ceiling-mounted light and fan fixture. Firefighters say a 3-year-old began crying because of the fire which alerted the child's older sister, age 10 to alert and tell her mother to call 9-1-1. response team from the department arrived to ensure that the fire was completely out. No one was injured during this incident.

## Three dogs rescued from burning truck at Walmart

An off-duty Hendersonville Police Department K-9 officer was loading his vehicle with groceries early Tuesday afternoon in the parking lot of Walmart when he heard a commotion several cars away. "Everyone kept hollering to get the dogs out," Sgt. Jimmy Case said. He then saw people around an older-model Ford F-250 truck with flames coming from the hood and smoke filling the cab, which held three dogs. Bystanders and store employees opened the unlocked door and let the two younger dogs, siblings Buddy and Ellie, out of the truck, but 14-year-old Ned didn't budge. "That old dog wouldn't jump out," said Case, who had to grab Ned out of the cab. A Walmart employee and a shopper grabbed fire extinguishers and quickly put out the engine fire. The owner of the truck was grateful for the good Samaritans who saved his dogs. "I think it's wonderful," said Jay Jones, who was in the store when the fire broke out. "The dogs are my life." Case has been a K-9 officer for 13 years and his partners are Zoro, a German Shepherd, and a bloodhound named Dixie. Fire officials said an electrical malfunction caused the fire.
