MISSION

KEY INITIATIVES



- Lead advocacy efforts to safeguard the public through lobbying activities and participation in code writing processes
- Provide top education opportunities, collateral, and resources
- Advance best industry standards and practices by promoting the principle that life safety is best served through "layered fire protection"

RECENT ADVOCACY ACCOMPLISHMENTS

- Worked to change state fire codes in more than 20 states to protect portable fire extinguishers in their fire codes and improved fire safety.
- Secured passage of legislation in Washington DC to improve fire safety for men and women in uniform by requiring US military bases across the world to match national model codes and to require portable fire extinguishers throughout buildings.

CURRENT ADVOCACY OBJECTIVES

- Working to push the General Services Administration, the federal agency charged with managing federal buildings and the largest landlord in the United States, to match national model codes and to require portable extinguishers throughout buildings. Currently, they are exempt from state fire codes and limit portable extinguishers to only hazardous areas such as boiler rooms.
- Working in Washington State to ensure trained professionals from fire extinguisher distributors can install, maintain and service pre-engineered extinguishing systems. The State Building Code Council is considering only allowing professionals trained on other fire protection systems to install and service these systems.
